Today, Blue Cross and Blue Shield companies cover:

- **79 of America's Fortune 100 employers**, including some of America's top companies like Walmart, Microsoft, General Motors and UPS.
- **6.9 million** people who work for small employers and are committed to helping small businesses manage their healthcare costs.

- **18 million** unionized workers, retirees and their families—the **#1 choice** for organized labor.
- **Millions** of Americans through government-supported healthcare programs, including:
 - **5.8 million** federal workers, retirees and their families through the Federal Employee Health Benefits Program—the top choice for federal workers
 - **4 million** through Medigap supplemental insurance
 - **11.1 million** through Medicaid programs
 - **4 million** through Medicare Advantage
 - **1.4 million** through Medicare Part D Rx drug plans

BCBS companies offer coverage through the Affordable Care Act marketplaces, and we also provide coverage through the Office of Personnel Management's multi-state plan.

BCBS companies have partnered with the federal government to process Medicare claims and payments since the program's inception in 1966. Today, Blue Medicare Administrative Contractors collectively handle more of the day-to-day work of paying Medicare claims than any other company.

DELIVERING BETTER CARE THROUGH INNOVATION

Blue Cross and Blue Shield companies believe our healthcare system should deliver safe, high-quality care; eliminate inefficient spending; and encourage and reward actions that individuals take to improve their health. Through innovative programs, the Blue System is improving care delivery and collaborating with physicians and nurses to help them choose evidence-based medical treatments that will best meet the unique needs of each patient.

- More than **67 million** BCBS members across **44 states and Washington, D.C.** have access to care from more than **580,000 providers** who are engaged with patient-focused care programs.
- Learning from the data that encompasses more than \$510 billion in annual claims nationally, BCBS companies provide free tools available on apps and online for consumers to compare costs for over 1,600 healthcare procedures – more than any other health insurer in the U.S. – to eliminate surprise out-of-pocket expenses and encourage price transparency.
- Blue Cross and Blue Shield companies offer a portfolio of performance-driven national network solutions that make it easier to design benefits for employers' specific needs, leveraging designated providers that meet nationally consistent criteria for quality and efficiency.
 - The **Blue High Performance Network (BlueHPN)** uses the local expertise, deep data and strong relationships of BCBS companies to partner with the right providers in each market to drive meaningful change toward better outcomes and value. BlueHPN offers a total cost of care savings of 11 percent on average (and up to 20 percent in some markets) in addition to the savings delivered by BlueCard PPO.
 - **Blue Distinction Specialty Care** focuses on doctors, hospitals and other healthcare facilities that excel in delivering safe, effective treatment for specialty procedures, such as knee and hip replacements, cardiac care, bariatric surgery and transplants.
 - **Total Care** focuses largely on primary care by recognizing doctors and hospitals that focus on the whole patient—emphasizing prevention and wellness, delivering more coordinated care and helping patients better manage chronic conditions.
